2. WE HAD ALWAYS CONSIDERED THAT APPROACH COULD BE THROUGH ANY ONE OF SEVERAL CHANNELS E G <sup>02</sup> [SIDEU-1], <sup>02</sup> [SEWER-1], <sup>02</sup> [REDACTED] OR EVEN DIRECT. SELECTION OF CHANNEL TO BE CONTINGENT UPON CONDITIONS LAID DOWN FOR MAKING CONTACT. BELIEVE COVER TO BE EMPLOYED BY FERNANDEZ AND INTENDED SUBSTANCE HIS DISCUSSIONS ARE FACTORS BE CONSIDERED IN DETERMINING CHANNEL.

3. SUGGEST BE BEST HAVE FERNANDEZ PROCEED JUAN WORK OUT WITH KARNLEY MEANS MAKING CONTACT. EXPECT THIS CAN BE QUICKLY ACCOMPLISHED. BELIEVE IT UNLIKELY SUBJECTS HAVE TIME OR INCLINATION GO WAVE. ADVISE.
