WHILE REALIZE CLARIFICATION OTI ROLE KINGSTON MAY POSE POSSIBLE PROBLEM IN SJAN RELATIONSHIP AMBANG-1, SUGGEST YOU INFORM AMBANG-1 REF RELUCTANCE HAVE OTI COOPERATE WITH KUBARK INCONSONANT HIS ORIGINAL REQUEST OUR SUPPORT. SHOULD BE EVIDENT TO AMBANG-1 WHO PROFESSED NEED UNITY IN ANTI-CASTRO EFFORT THAT UNCOORDINATED EFFORT WITH VARIOUS INDIVIDUALS HITTING SAME TARGETS NOT LIKELY PRODUCE RESULTS.
