1. Transmitted herewith as requested in referenced memorandum are four TSD-prepared PBRUMEN documents showing issue in the name of Juan CARDENAS Mendez. Instructions concerning their use and other pertinent information can be found in Attachment 2. We are also returning the photographs and one of the negatives as requested.

2. Except for the agent's signature and aging, three of the documents are ready for operational use. Per conversations between Mr. [redacted] of TSD/DB and Mr. Rodriguez, additional negatives of the agent in a different pose will be required to complete the driver's license. It is therefore requested that additional ID photos be taken. 03

3. We would also like to have at least three specimens of the agent's alias signature in the event it becomes necessary to forge other documents in this name either while the agent is in place or otherwise unavailable to sign them himself.

4. IMPORTANT: Please return the four documents to TSD/DB for validation and final checking.

1. The following documents have been prepared in the name of Juan CARDENAS Mendez and are based on valid PBRUMEN exemplars and information available to TSD/DB:

Carnet G-No. 11473 - SINDICATO NACIONAL DE TRABAJADORES DE BANCOS Y SEGUROS

Carnet de Identidad G-No. 11473 - CIRCULOS SOCIALES CTC-R

Carnet Laboral - A No. 750389

Licencia de Conduccion - 472628 w/plastic cover

2. Entries found in the documents support the story that Juan CARDENAS Mendez is single, resides in Vedado, works as a teller in a bank located in Marianao and can operate an automobile. The two Carnet G-documents are related and were issued sometime in December 1962 when, according to his date of birth, the agent was 32 years old. The names of his parents seen on the back of the CIRCULOS SOCIALES card were chosen by TSD/DB. His Carnet Laboral was issued in mid-1962 and the driver's license sometime in mid-1963. These documents are not backstopped and should be used for identification purposes only. The agent should be instructed to study his documents, memorizing important entries such as dates and place names. He should have complete confidence in them.

3. To complete the fill-in the agent should sign his documents, in alias, as follows:

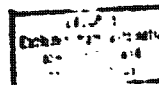
Using any blue or blue-black ballpoint pen, sign on the front of the two Carnet G-documents on the dotted lines above FIRMA DEL AFILIADO and FIRMA DEL TRABAJADOR.

With a different pen, not necessarily ballpoint, sign on the line after FIRMA on the opening page and again on page 1 after FIRMA DEL TRABAJADOR of the Carnet Laboral.

The driver's license should be signed with a third pen on the tab marked TALON PARA RENOVAR on the line above FIRMA DEL INTERESADO.

IMPORTANT - The agent must sign in alias five times. Before EACH time he should practice on a separate sheet of paper.

4. The driver's license was issued in mid-1963 and expires on 30 November 1964. It shows that this is the bearer's first license and that he must wear glasses while driving. He is not licensed to drive a truck or act as a chauffeur.
