FIELD REPORT NO. UFG 5827

A GROUP OF CUBAN EMIGRES TRAINED IN THE TECHNIQUES OF INFORMATION COLLECTION. THE GROUP HAS PROVIDED USEFUL REPORTS FOR ABOUT THREE YEARS. THIS INFORMATION WAS OBTAINED FROM JOSE GARCIA VALDEZ, AKA "PEPE GATILLO".

1. ON 9 SEPT '64 JOSE GARCIA VALDEZ, AKA "PEPE GATILLO", SAID THAT MANUEL RAY RIVERO, LEADER OF THE JUNTA REVOLUCIONARIA CUBANA (JURE, CUBAN REVOLUTIONARY JUNTA), HAD ASKED GARCIA TO TAKE RAY, PHOTOGRAPHER ANDREW ST. GEORGE, AND MIRTA BORRAS ON A TRIP TO AN UNSPECIFIED DESTINATION.
2. THE GROUP IS TO DEPART AT 1000 ON 10 SEPT IN A CATAMARAN, REGISTRATION CT-12080, WHICH BELONGS TO JURE AND WHICH IS NOW AT THE INTERNATIONAL MARINE DOCKS BEING FUELED AND PREPARED FOR THE TRIP.
3. FIELD DISSEM: CINCLANT, CINCSO, COMKWESTFOR, MIAMI REPS OF STATE, FBI, CUSTOMS, I&NS, BORDER PATROL, AND USCG.
