1. FOLLOWING DETAILS AVAILABLE TO DATE FROM 513TH INVESTIGATION SUBJ DEFECTION:		
A. SUBJ ACCESS TO CLASSIFIED INFO LIMITED TO COLLECTION OF PUBLICATIONS.		
B. SUBJ'S DUTIES CONFINED TO CLASSIFYING, FILING AND LISTING PUBLICATIONS COLLECTED THROUGH OVERT MEANS. HE DID NOT CONTACT SOURCES FOR MATERIAL. HE DID SOME TRANSLATING OF DOCUMENTS. SUBJ'S DUTY CONSIDERED LEAST SENSITIVE IN UNIT.		
C. 513TH OPINION IS THAT SUBJ CAN GIVE NOTHING OF VALUE TO SOVIETS EXCEPT PERSONALITY DATA RE CAMP KING PERSONNEL, WHICH SOVIETS CAN PROBABLY ACQUIRE ANYWAY FROM PEOPLE PLACED IN CAMP KING - MARIENFELDE STREAM.		
D. DUTIES DID NOT BRING SUBJ IN CONTACT WITH COLLECTION AND CE PERSONNEL.		
2. ALL OR PARTS ABOVE MAY BE PASSED <sup>DI</sup> [UPHILL] AT YOUR DISCRETION. WITH RESPECT QUESTION WHETHER SUBJ KNOWLEDGEABLE <sup>DI</sup> [UPHILL] - CAMP KING RELATIONS, SUGGEST <sup>DI</sup> [UPHILL] INSTRUCT ALIAS LORING TO QUERY 513TH DIRECTLY.
