- ON 7 JAN WHILE AM-2 AT EMBASSY GATE WITH HESBERTO JORRIN MUNOZ (NOTE CORRECT FIRST NAME SPELLING), NEGRO GATEKEEPER, SEVERAL WOMEN APPROACHED COMPLAINING THEY HAD NOT BEEN GIVEN TICKETS TO GO HAVA AT CUBANA AIRLINES OFFICE. ARMONA APPEARED SHORTLY AFTER, EXPLAINED SITUATION, AND GAVE LEADER GROUP 60 DOLLARS FOR EACH WOMAN. ARMONA ASKED WOMAN FOR RECEIPT WHICH GIVEN JORRIN WHEN ARMONA HAD TO LEAVE.
