**SECRET NO FOREIGN DISSEM BACKGROUND USE ONLY**

1. TWO UNTESTED INFORMANTS WHO ARE MEMBERS OF ALPHA 66 REPORTED TO REPRESENTATIVES OF THE AGENCY THAT A SCHEM RECENTLY DEVELOPED IN THE ALPHA 66 RANKS OWING TO THE DECEPTIVE TACTICS OF ANTONIO VECIANA BLANCH, A FOUNDER OF ALPHA 66. SINCE THE CREATION OF ALPHA 66 VECIANA HAS BEEN SECRETLY ASSOCIATED WITH THE SEGUNDO FRENTE DEL ESCAMBRAY (SFDE) BUT DID NOT REVEAL THE RELATIONSHIP TO THE MEMBERS OF ALPHA 66. VECIANA HANDLED ALL FUND DISBURSEMENTS AND ALWAYS SPOKE OF FINANCING ANOTHER GROUP, BUT ALPHA 66 THMEMBERS THOUGHT THE OTHER GROUP WAS A PART OF ALPHA 66. (CONTINUED)

2. ACCORDING TO THE INFORMANTS, THE TRUTH CONCERNING VECIANA'S SECRET RELATIONSHIP WAS NOT REVEALED UNTIL LATE OCTOBER 1963 WHEN VECIANA AND ARMANDO FLEITES DIAZ, SECRETARY GENERAL OF THE SFDE, OFFERED THEIR SERVICES AND RESPECTIVE ORGANIZATIONS TO JOSE MIRO CARDONA, HEAD OF THE CUBAN REVOLUTIONARY COUNCIL. THEY TOLD MIRO THAT BOTH ORGANIZATIONS HAD FORMED A PACT AND THAT ELOY GUTIERREZ MEMOYO WAS BEHIND BOTH ORGANIZATIONS AND HAD DONE THE PLANNING OF ALL ALPHA 66 AND SFDE OPERATIONS AGAINST CUBA. BEFORE THE MEETING WITH MIRO VECIANA REVEALED HIS SECRET RELATIONSHIP WITH THE SFDE TO SEVERAL ALPHA 66 MEMBERS AND ATTEMPTED TO OBTAIN THEIR COOPERATION. THEY REFUSED AND URGED HIM TO BREAK WITH THE SFDE IMMEDIATELY. THE VECIANAS REFUSED TO DO AND FURTHER ALLEMIATED THE ALPHA 66 MEMBERS BY MEETING WITH MIRO THUS ALPHA 66 MEMBERS AND FINANCIAL SPONSORS FELT THEY WERE DUPED BY VECIANA AND ASKED HIM TO RESIGN FROM ALPHA 66, WHICH HE DID. VECIANA SUBSEQUENTLY TRAVELED TO SAN JUAN, PUERTO RICO TO

APPEAL HIS CASE TO ALPHA 66 SPONSORS THERE, BUT HIS EFFORTS FAILED. AN ACCOUNTING OF FUNDS SHOWED HE DIVERTED \$27,000 TO THE SIDE OUT OF THE TOTAL ALPHA 66 FUND OF \$37,000.

2. THE INFORMANTS REPORTED ALPHA 66 IS NOW COMPLETELY DIVORCED FROM THE DSFDE; IT IS APOLITICAL; SEEKS ONLY TO FIGHT CASTRO THROUGH MILITARY ENDEAVOR; UNDER THE CHARTER NO MEMBER CAN HOLD OFFICE IN A FUTURE CUBAN GOVERNMENT; AND THE TOTAL STRENGTH OF THE ORGANIZATION IS NOW TWENTY. ALPHA 66 IS PRESENTLY INSOLVENT AND HOPES TO BEGIN AND INTENSIVE APPEAL FOR ADDITIONAL FUNDS SOON. ALL ALPHA 66 EQUIPMENT WAS LOST ON THE ILL-FATED 23-24 OCTOBER 1963 ATTEMPTED RAID TO SABOTAGE SUGAR BARGES OFF CAYO SANTA MARIA. BECAUSE OF ROUGH SEAS BOTH ALPHA 66 IN BOATS SANK NEAR THE LIGHTHOUSE ON BAYO CAIMAN GRANDE. THE MEN SWAM ASHORE, STOLE A BOAT, AND RETURNED SAFELY.

4. ALL ALPHA 66 OPERATIONS ARE CARRIED OUT FROM MIAMI, AND EXTREME CARE IS EXERCISED TO KEEP THIS FACT A SECRET. ALPHA 66 HAS ALSO USED CAYO ANGUILA AS AN OPERATIONAL BASE, BUT

WILL CHANGE SOON TO ANDROS ISLAND. THE MEMBERS HOPE TO BUY A MOTHER SHIP IN THE FUTURE TO SERVE AS A MOBILE BASE. THEY ALSO NEED A BOAT CAPABLE OF FORTY TO FIFTY KNOTS SPEED AND EQUIPPED WITH RADSO AND RADAR FOR FAST OPERATIONS. FABRICATED ARMS AND EXPLOSIVES ARE ALSO NEEDED TO CONDUCT EFFECTIVE RAIDS.

5. THE INFORMANTS ALSO REPORTED THAT THE FROGMEN WHO EXPERIENCED THE REPELLING FORCE FROM THE SOVIET SHIP DURING THE ALPHA 68 RAID AT SAGUA LA GRANDE ON 8 OCTOBER 1962 WERE SFDE MEMBERS.

6. THE ABOVE INFORMATION IS BEING MADE AVAILABLE TO THE IMMIGRATION AND NATURALIZATION SERVICE, TO THE BUREAU OF CUSTOMS, TO THE BUREAU OF INTERNATIONAL PROGRAMS OF THE DEPARTMENT OF COMMERCE, AND TO THE U. S. COAST GUARD.
