- 1. Reference is made to the name check request dated 19 September 1962, subject as above, whose name you desired checked against the files of this office for information relative to Subject's possible involvement in arms shipments to Ecuador in 1959.
- 2. This office has no specific information which would indicate that Subject was involved in plans or activities to ship arms to Ecuador in 1959.
- 3. During August and early September 1962 Subject was in several Central American countries. His principal activity appeared to be contacting officials of the Governments of Guatemala, Nicaragua, and El Salvador for the purpose of obtaining recognition of a de facto Cuban Government in exile called the "United Organization for the Liberation of Cuba" Information concerning Subject and his recent activities and associates in Central America will be forwarded by another component of this office.
