1. MITCHELL LIVINGSTON WEBB BELL, BORN 1918, SERVED IN OSS DURING WORLD WAR II, HAD OWN ADVERTISING AND PUBLIC RELATIONS BUSINESS IN ATLANTA, GA. WENT BANKRUPT IN 1959. HE TRAVELLED TO DOMINICAN REPUBLIC 1959 AND BECAME INVOLVED WITH ANTI-CASTRO PLOTTERS. WAS GRANTED POA 4 AUGUST 1959 TO FURNISH INFO ON REVOLUTIONARY MATTERS IN CARIBBEAN AREA. HIS INTELLIGENCE WAS OF LITTLE VALUE AND HIS KUBARK SERVICE TERMINATED OCTOBER 1959. WAS ASSESSED AS WHEELER AND DEALER, AND ON SEVERAL OCCASIONS ATTEMPTED HAVE KUBARK FINANCE HIS TRAVELS TO DOMINICAN REPUBLIC. HE REPORTED IN JULY 1959 THAT AN AMERICAN BUSINESSMAN NAMED JONES, FNU, WHO HAD BUSINESS IN EUROPE AND WAS IN MIAMI BUYING REAL ESTATE, HAD MENTIONED TO HIM THE POSSIBILITY OF OBTAINING SERVICES OF 1000 EXPERIENCED GERMAN COMBAT TROOPS AT RATE OF \$100 PER DAY PER MAN FOR ANTI-CASTRO EFFORTS. NO INFO ON WEBB BELL SINCE OCTOBER 1959.

2. ODENVY REPORTED IN JUNE 1960 ONE ARTHUR L. SMITH WAS MEMBER OF JONES AND HANDY MARINE ARCHITECT FIRM, MIAMI, FLA.

SMITH HAS TRAVELLED TO CUBA SEVERAL TIMES SINCE JANUARY 1959, LAST TIME IN MARCH 1960. FIRM WAS CONDUCTING SURVEYS IN ORIENTE PROVINCE FOR PURPOSE CONSTRUCTING STEEL MILL. HOWEVER PLANS HAVE BEEN ABANDONED. NO INFO ON SMITH SINCE MARCH 1961.

3. MAJOR MANUEL PINEIRO LOSADA IS ASSISTANT CHIEF CUBAN G-2 AND WELL KNOWN MEMBER CASTRO'S ENTourage. HIGHLY UNLIKELY HE WOULD TRAVEL OPENLY TO GUAT AND ~~BE IDENTIFIED~~ <sup>ALMOST EQUALLY UNLIKELY WOULD GO</sup> THERE BLACK. HQS CANNOT IDENTIFY ANY EXILE NAMED PINEIRO WHO MAY BE TRAVELLING GUAT.

4. PLEASE ATTEMPT MONITOR ACTIVITIES OF WER BELL, SMITH, AND PINEIRO.

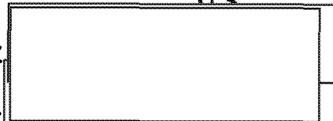

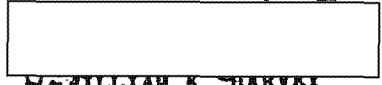
