1. AMCONCERT-1 LEARNED FROM (LUCIA ECHEVARRIA) BIANCHI'S FATHER THAT SUBJ REF HAD RECD P... TARD FROM FLORENDO CUBELA. A-1 INSTRUCTED CALL SUBJ AFTERNOON 6 JULY. SUBJ TOLD A-1 HAD RECD CARD MAILED CANADA BUT WOULD NOT GIVE DETAILS AND REQUEST A-1 CALL LATER EVENING.
2. SLOMAN PRESENT WHEN SECOND CALL MADE AND SUBJ WOULD NOT GIVE INFO THEREFORE SAOMAN REQUESTED TALK WITH SUBJ. SLOMAN WAS PRESENTED AS ENRIQUE, KNOWN BY SUBJ'S FATHER, HAVING LIVED IN HOME OF ENRIQUE AND HAVING UNSUCCESSFULLY ATTEMPTED TO CONTACT CUBELA.

5. SUGGEST MAY BE ADVISABLE HCS CLARIFY STATUS SUBJ WITH ODENVY IF NOT DONE AT TIME POA TRACE CONDUCTED. STATION BELIEVES THIS OP MORE KUBARK REALM THAN ODENVY'S.

6. SUBJ KNOWS ANDREW F. MERTON BY TRUE NAME. A-1 WILL CALL SUBJ 10 JULY, DATE WHICH SUBJ PLANS RETURN FROM CANADA, AND WILL SUPPLY NAME HARVEY THOMPSON AS MAN WHO WILL MAKE CONTACT.
