1. ANSHIP/2 telephoned BUNCK's house on 10 December 1964 and invited BUNCK and wife to dinner the following evening. On 11 December 1964 BUNCK picked him up at the store. En route to BUNCK's place, and also at the close of the evening, ANSHIP/2 supplied the following information.
2. With the help of a good lawyer and some influential friends ANSHIP/2 has finally managed to obtain official permission to reside indefinitely in Geneva. He is moving to a larger apartment sometime after the holidays.
3. He will be back in Rome in early January 1964, without ANSHIP/1 (who was at the store when BUNCK picked up ANSHIP/2). He will give BUNCK the completed Plan I at that time. When BUNCK expressed some mild skepticism (because ANSHIP/2's past visits to Rome have been much more widely spaced than he thought they were going to be), he repeatedly earnestly that he had to be back in January for business reasons.
4. BUNCK asked whether ANSHIP/2 and wife had had a visit in Geneva from Comandante Juan ALMILLA Bonquet. (See SAVZ-4021, 30 October 1964, not to Garcia) ANSHIP/2 said no. He also said that neither he nor his wife had had any correspondence from ALMILLA. He repeated some of the information about ALMILLA which appears in Reference and added that while he (ANSHIP/2) and wife were still in Cuba, his wife's brother was arrested for possession of a radio receiver. The wife went to ALMILLA, who was indignant and who promptly ordered the brother's release. ANSHIP/2 again describes ALMILLA as a simple but honorable and trustworthy man.

5. BUNCE also asked about the invitation extended to AMWHIP/2 by the Cuban regime to visit Cuba (see DIR-49887, 15 September 1964, not to JMWAVE, Paris) (Bern) or Geneva) AMWHIP/2 confirmed that he had been extended such an invitation and that he also wanted to accept. Had he gone? His contact would have been with the feu IGLESIAS who appears in (IRA) 37300, 7 August 1964 (not to JMWAVE or Bern) AMWHIP/2 explained that had he gone, he would have been able to see all the jewelry that the GOC has for sale and not just those pieces which it sends to Europe. He said that he had checked with AMWHIP/1, who later told him that for security reasons he should not make the trip.

6. Does Headquarters have any questions about which it is desired that AMWHIP/2 be queried during his next trip to Rome?

a. If Headquarters continues to have a pressing need for Cuban pesos (per DIR-67711, 2 December 1964), we could ask AMWHIP/2 whether he can obtain them without hazard and at what price.

b. We could also query him concerning any cases he may know about which involve financial corruption on the part of any Cuban officials or bank accounts maintained by any such officials outside Cuba.

c. We intend to ask for full details on AMWHIP/1-AMWHIP/2 purchases of jewelry from the Cuban Ambassador in Paris unless Headquarters already has all this information from AMWHIP/1. Please advise.

d. We plan to debrief AMWHIP/2 systematically on any acquaintances or friends whom he may have in Cuba and who have an operational potential.

e. We also plan to ask him for any vulnerability data he may have on Cuban officials abroad.

7. If all or most of the above cannot be covered during AMWHIP/2's January trip to Rome, BUNCE plans to go to Geneva in February per paragraph nine of Reference.
