1. SCORCORY, USING NAME ANDRES SANDERS, MET BLANCO (SUBJ REFS) 10 SEPT. SUBJECT AT FIRST ADVANT DLE OO REFUSAL SHOU KUBARK BONAFIDES, BUT PROVIDED INFO BELOW DURING TWO HOUR MEET IN MADRID PARK.

2. SUBJECT BACKGROUND: FIRST LEFT CUBA FOR MIAMI 1952 WITH FATHER WHO POLIT LEADER UNDER PRIO. SPENT MOST TIME ENGAGED ANTI-BATISA ACTIVITY, INCLUDING ARMS DELIVERED TO FIDELISTAS IN ESCAMBRAY PRIOR 1959. ENLISTED USAF AND DISCHARGED OCT 56 FOR MEDICAL REASONS; CITED "SERIOUS CONDITION" AND "RESISTANCE". WIFE WAS ⁰⁶ (MARY LARRIN) BORN ⁰⁹ TUBSON CA (1931), WHO DIVORCED HIM FROM MIAMI 1963 FOLL THREE YEAR SEPARATION. BECAME CAPTAIN SMALL ARMY FOLL CASTRO TAKEOVER. MAY 59 WENT WITH INVASION FORCE TO MIAMI, CAPTURED AND THROWN INTO PRISON MANAGUA NEXT MORNING. ON RETURN TO US WIFE CO ATTEMPTED BY G-2 FOR DISCIPLINARY REASONS SINCE MARY LARRIN WIFE WERE DID NOT HAVE FIDEL BLESSING, SPENT THREE MONTHS LA CAJON PRISON. WIFE DEC 61 TO NOV 63 EMPLOYED CIUDAD (MEXICO) AS A STENOGRAPHER AND (ADMIN AND PAYMASTER) ⁰⁸ UNTIL DEPARTURE BY TRAIN SEPT 64 ACTING AS WIFE LANCE SALESMAN AND ENTERED SOME

3. (CHOMON) FIRST PROPOSED G-2 MISSION OCT 53, HOWEVER, DID NOT ACCEPT UNTIL AUG 54 WHEN (CHOMON) INTRODUCED HIM (MAJOR GUILLERMO JIMENEZ) CHIEF INTERNATIONAL SECTION. CIS CASE OFFICER WAS "LUCIO", WITH WHOM HAD FOUR CONTACTS VARIOUS SAFEHOUSES HABANA AREA, ONE LOCATED 12TH FLOOR CALLE 3 AND F, VEDADO. SUBJ NOT GIVEN ANY TRAINING OTHER THAN BRIEFING RE MISSION PENETRATE CUBAN EXILES SPAIN, U.S. SAID WAS FURNISHED FOLL ACCOMMODATION ADDRESS ORDER WRITE TO "LUCIO".

4. SUBJ SAID TWO OR THREE AGENTS DISPATCHED MONTHLY BY CIS, BUT UNABLE IDENTIFY ANY.

5. SAID INTERVIEWED TWICE BY (QUOTA) "ON BASIS BEING EX ARMY OFFICER" AND LOGICAL SUSPECT, HOWEVER, CLAIMS DID NOT REVEAL PENETRATION ROLE. TOLD (QUOTA) HE OLD FRIEND (QUOPS 1) (QUALT 1) AND PLANNED SEE THEM OCCASSIONALLY. (QUOTA) COURTEOUSLY REQUESTED HIM PROVIDE ANY INFO RE FUTURE CONTACTS CUBAN EMB.
