ON 19 MAY AMMUG/1 MENTIONED THAT A MIAMI NEWSPAPER ARTICLE ABOUT JOSE IGNACIO MARTE POLANCO IN EARLY MAY HAD REMINDED HIM HE KNOWS MARTE WAS TRAINED IN CUBA BECAUSE HE HANDLED HAVANA FILES RELATED TO HIM. ALTHO AMMUG/1 HAD REPORTED THE SETTING UP OF CLANDESTINE STATION IN DOMINICAN REPUBLIC HE HAD FORGOTTEN MARTE NAME. NEVER MET MARTE. ALSO RECALLED TWO OTHER MEN INVOLVED WITH MARTE IN INFILTRATION OF COMMO EQUIPMENT IN DOMINICAN REPUBLIC DURING HURRICANE FLOPA, OCTOBER 1963. THEY WERE CAYETANO RODRIGUEZ DEL PRADO (201-734726) AND LEOPOLDO GRULLON RUIZ (201-752013). MARTE ALSO CLOSE FRIEND OF ROBERTO SANTIESTEBAN CASANOVA (201-543896) KNOWN AS "RAFAEL".
