He had participated in five infil operations undertaken independent of KUBARK in connection with a revolutionary group from September 1958 through June 1961. His motivation toward KUBARK is based at least partly on the salary he has received since April 1962.</p>	
<p>2. INDICATE WHAT CONTROL, IF ANY, EXISTS OVER THE SUBJECT. (If no control, or if there is a lack of real control explain.)</p> <p>KUBARK control is exercised through AMICE leaders and is partly dependent upon monetary considerations.</p>

<p>3. EXPLAIN ANY TRAINING SUBJECT HAS HAD IN CLANDESTINE OPERATIONS.</p> <p>KUBARK training in demolition, 45-calibre pistol, M-1 rifle, M-3 A-1, BAR, compass, caching and base procedure (Fair/Good)</p>
