1. DEVELOPMENT DESCRIBED REF CONVINCING PROOF THAT ENTIRE AMLASH GROUP INSECURE AND THAT FURTHER CONTACT WITH KEY MEMBERS OF GROUP CONSTITUTES MENACE TO KUBARK OPS AGAINST PBRUMEN AS WELL AS TO SECURITY KUBARK STAFF PERSONNEL WESTERN EUROPE.

2. UNDER CIRCUMSTANCES HQS DESIRES THAT CONTACT WITH KEY MEMBERS OF GROUP BE ELIMINATED AS RAPIDLY AS POSSIBLE, AND THAT ASSETS WHO MAY BE IN CONTACT WITH INDIVIDUAL MEMBERS OF THE GROUP OR INDIVIDUALLY INVOLVED IN AMLASH CONSPIRACY BE WARNED OF DANGER IMPLICIT IN THESE ASSOCIATIONS AND DIRECTED TO ELIMINATE CONTACTS ASAP.

3. INDIVIDUALS IN WESTERN EUROPE CONSIDERED KEY MEMBERS OF GROUP ARE AMLASH/2, ^{or} (US)XAFU/9. (PARI: CONCUR TERMINATION ^{or} (US)XAFU/9 PER PARI 1665, HOWEVER WISH NO FURTHER CONTACT AFTER TERMINATION.)

4. THOUGH NOT A KEY MEMBER OF AMLASH GROUP ^{or} (US)XAFU/9 HAS BEEN ASSOCIATED WITH GROUP MEMBERS. THIS HQS CONCERNED HOW DEEPLY ^{or} (US)SPORT/1 COMMITTED TO AMLASH GROUP AND DEGREE TO WHICH HE COMPROMISED BY GROUP'S INDISCRETIONS. BELIEVE EXHAUSTIVE DEBRIEFING, REASSESSMENT AND LCFLUTTER ^{or} (US)SPORT/1 WILL BE NECESSARY TO DETERMINE HIS BASIC LOYALTIES

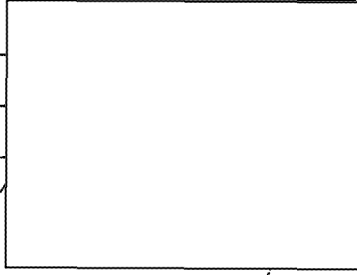
