IF IT WILL NOT INVOLVE DELAY IN QJWIN'S DEPARTURE FOR LEOP, HAVE HIM OBTAIN VISA FOR DAKAR SAME TIME HE OBTAINS FOR BRAZZAVILLE. OTHERWISE, HE CAN OBTAIN DAKAR VIA BRAZZAVILLE ON COMPLETION MISSION LEOP.
