- 2. Source described Rosita as being the daughter of a wellknown Departamento de Seguridad del Estado (Department of State Security - DSE) official or a DGI official, but more likely DSE. She is a synthetic strawberry blond and is about five feet six inches tall. $^{\rm I}$
