- 1. Almost all of the Cubana Airlines personnel belong to or work with the Departmento de Seguridad del Estado (Department of State Security DSE). However, what services Cubana personnel perform for the intelligence agencies are not known.
- 2. According to Source, when the Cuban government first took over Cubana Airlines, the personnel chief of the new administration interviewed girls from the G-2 office for positions as stewardesses.
