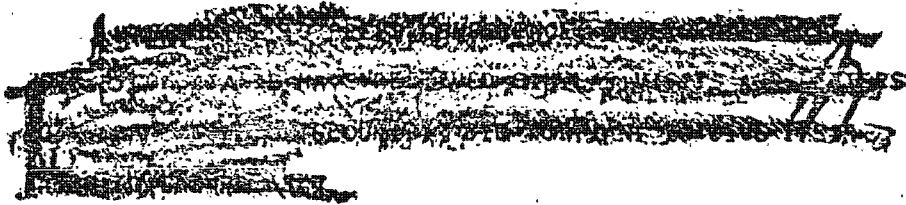

"EL CARIBE", 21 SEPT 66, PUBLISHED AN INTERVIEW WITH SEVERAL FORMER CONSTITUTIONALIST COMBATANTS HELD THE PRECEDING DAY, DESCRIBING AN OFFER FROM FOREIGN CITIZENS OF SEVERAL COMBATANTS TO ACT AS INFORMERS ON BEHALF OF AN UNAS. ACCREDITED TO DOMREP. NAME OF EMBASSY OR FOREIGN NATIONALS NOT DISCLOSED. SPOKESMAN FOR GROUP WAS FORMER COMRADE FRANCISCO JAVIER "PICHI" NELLA PERAZ.

2. NELLA STATED HE WAS APPROACHED BY MAN WITH CUBAN ACCENT WHO TALKED KNOWINGLY ABOUT NELLA'S "PAST LIFE", AND SAID NELLA TO SERVE AS INFORMANT, OFFERING IN RETURN THREE THOUSAND PESOS PLUS THREE TO FIVE HUNDRED PESOS MONTHLY. NELLA DESCRIBED TELEPHONE INSTRUCTIONS GIVEN HIM FOR CONTACT, INCLUDING NUMBER AND NAMES TO BE USED, AND MADE AVAILABLE TO PRESS A LETTER SENT HIM BY ONE "VICTOR" WHICH REMINDED HIM HE HAD NOT ESTABLISHED TELEPHONE CONTACT, AND A PERSON LETTER, ALSO FROM "VICTOR" STATING, "IN THREATENING TONE", THIS

... ACCEPT OPPORTUNITY PROVIDED HIM.
ANOTHER FORMER COMBATANT STATED THAT CAPTAIN ARIAS COLLADO
AND FORMER CONSTITUTIONALIST COMANDANTE RAMON NEJIA
"PICHIRILO" WERE ALSO SENT SIMILAR LETTERS AND, IN NOT
ACCEPTING THE OFFER, "THE DOMINICAN PEOPLE KNOW WHAT
HAPPENED." (RAMON NEJIA "PICHIRILO" WAS SHOT BY UNIDENTIFIED
ASSAILANT IN DOWNTOWN SANTO DOMINGO.)
