BELOW IS A TRANSLATION OF PART OF A LETTER WHICH ROOME DALTON CARCIA SENT TO "DIARIO HE MOY" AND MAJOR THIS HERSPAPER PUBLISHED 33 OCT 64: "THERE (COMMENT: IN COLUMNIED THEY LOCKED ME IN A COLD. HE SAID HE MAD ARRIVED IN THE COUNTRY FARTICULARLY TO DEAL WITH MY CASE, THE FROM IMPORMATION I GOT LATER I MUST ASSUME THAT UP IS ONE OF THE FOREIGN 'ADVISORS' TO THE POLICE AND OTHER NATIONAL MILITARY INSTITUTIONS. THIS MAN ACCUSED ME OF PARTICIPATING IN AN INTERNATIONAL PLOT AGAINST THE SALVADORAN COVERNMENT CORRECTED, OF COURSE, AND ACCORDING TO THE ACCUSATION, MON C'MA), AND AROUT WHICH THURE WAS ASHIDANT PROOF. INCREASING HIS THREATS AND OFFERS, AND GOING SO FAR IS TO INTRODUCE ME TO A PERSON COMPLETELY UNKNOWN TO ME WHO SPOKE HITH'A STRONG CUMAN AGCENT, AND WHO. VERY CURTLY AND IN MY PRESENTA.
