<p>Ref: HMM-11843</p> <p>1. Mexico City Station appreciates Headquarters' prompt processing and renewal of Project LIFEAT.</p> <p>2. In regard to the comments made by KUTUBE/INT and forwarded by reference, the Station wishes to note that LIFEAT coverage is devoted primarily to support the Station's CE program and the Station's operational program as well as to cover targets the Station wishes done [redacted] Very little information of a positive intelligence nature is provided from this type of target line.</p> <p>3. It is further noted that Soviet, Bloc and Cuban coverages, which do provide disseminable intelligence, are covered by LIENVOY except in the case of Yugoslav and Polish coverage. Yugoslav coverage is presently being shifted to LIENVOY. It was during the period when LIFEAT covered the Soviet and Czech official installations that a greater number of disseminations (noted in paragraph 2 of reference) were made from LIFEAT material.</p> <p>4. As to the "routine" interest of Subjects covered by LIFEAT, it was the opinion of the Station that LIFEAT take, such as that on ESLARD-1, was of interest to Thomas A. BUELT and of some interest to OPIDEAL himself.</p> <p>5. In view of the coverage presently provided by LIENVOY, it is Station's opinion that LIFEAT's best contribution will remain in providing [redacted] coverage keyed to the support of the Station's operations and special Headquarters requests (such as coverage of persons of ZRICHICK interest). In the event it becomes necessary or desirable that LIFEAT shift its operational emphasis, the LIFEAT complex is ready to accomplish this operational re-adjustment rapidly.</p> <p style="text-align: right;"><i>Willard C.
