FIELD REPORT NO. UFG 7738

A CUBAN WELL KNOWN IN THE MIAMI EMIGRE COMMUNITY WHO HAS INTERNATIONAL SHIPPING INTERESTS. SOURCE'S REPORTING ON MARITIME ACTIVITIES IN THE CARIBBEAN HAS BEEN TIMELY AND RELIABLE. AS OF ABOUT JUNE 1965 HIS REPORTING ON OTHER TOPICS HAS IMPROVED IN DEPTH AND SIGNIFICANCE

1. ON 18 NOVEMBER 1965 THE PUERTO RICO BRANCH OF COMANDOS L WAS PLANNING TO STAGE A RAID ON CUBA SIMILAR TO THAT WHICH TOOK PLACE 14 NOVEMBER. (FIELD COMMENT. THE MIAMI HERALD REPORTED THAT COMANDOS L, CUBAN REPRESENTATION IN EXILE, AND THE FRANK PAIS MOVEMENT CLAIMED CREDIT FOR THE RAID ON THE COAST OF HAVANA ON 14 NOVEMBER.) A 57MM CANNON WILL BE USED IN THE PLANNED RAID. (FIELD COMMENT. A RECENT REPORT FROM AN INDEPENDENT SOURCE REPORTED THAT THE COMANDOS L PLAN TO CONTINUE RAIDING CUBAN TARGETS AT THE RATE OF ONE EACH WEEK.)

 LORLANDO BOSCH AVILA, MEMBER OF THE MOVIMIENTO INSURRECCIONAL DE RECUPERACION REVOLUCIONARIA (MIRR, INSURRECCIONAL MOVEMENT FOR REVOLUTIONARY RECOVERY), IS PLANNING AN ATTACK ON CUEA WHICH WILL TAKE PLACE IN THE NEAR FUTURE. ADOLFO JIMENEZ AGUILERA HAS BEEN ASKED TO PARTICIPATE IN THE OPERATION. (FIELD COMMENT. MIRR'S RECENT PLANS FOR ACTION HAVE BEEN FOR ATTACKS ON SHIPS INVOLVED IN THE CUBAN TRADE. HOWEVER, A RECENT REPORT FROM AN INDEPENDENT SOURCE REPORTED THAT ON 15 NOVEMBER WHEN BOSCH DISCUSSED THE 14 NOVEMBER RAID, HE COMMENTED THAT THIS IS A FAVORABLE TIME FOR COMMANDO-TYPE ACTION AGAINST CUEA.)
