FIELD REPORT NO.

1. ON 13 OCTOBER 1965 ORLANDO BOSCH AVILA, LEADER OF THE MOVIMIENTO INSURRECCIONAL DE RECUPERACION REVOLUCIONARIA (MIRR, INSURRECTIONAL MOVEMENT OF REVOLUTIONARY RECOVERY) SAID THAT THE MIRR WILL CONTINUE TO ATTACK SHIPS OF COUNTRIES WHICH TRADE WITH CUBA, AND NEXT THEY WILL ATTEMPT TO ATTACK A SHIP IN A PORT IN THE UNITED STATES.

2. (FIELD COMMENT: A RECENT REPORT FROM THE SAME SOURCE, BUT A DIFFERENT SUBSOURCE, REPORTED THE PLANS OF THE MIRR TO "DECLARE WAR" ON ALL COUNTRIES WHICH TRADE WITH CUBA BY ATTACKING SHIPS IN

THE CUBAN TRADE. THE MIAMI HERALD OF 13 OCTOBER REPORTED THAT BOSCH CLAIMED CREDIT IN THE NAME OF THE MIRR FOR THE 10 OCTOBER EXPLOSION ABOARD THE SPANISH VESSEL SATRUSTEGUI, AT SAN JUAN PUERTO RICO. BOSCH ALSO SAID THAT AN ATTEMPT TO BLOW UP A BRITISH FREIGHTER IN A LATIN AMERICAN PORT HAD FAILED BECAUSE OF A DEFECTIVE DETONATOR. ANOTHER RECENT REPORT, FROM THE SAME SOURCE BUT A DIFFERENT SUBSOURCE, REPORTED THE PLANS OF THE MIRR TO ATTACK A JAPANESE VESSEL AT A PORT IN VENEZUELA. TDCSDS-315/02687-65, DATED 12 AUGUST 1965, FROM A DIFFERENT SOURCE, REPORTED THE PLANS OF THE MIRR TO ATTACK A VESSEL IN JACKSONVILLE, FLORIDA, ON 24 OR 25 AUGUST 1965. THE ATTACKS ON THE JAPANESE VESSEL OR ON VESSELS IN JACKSONVILLE HAVE NOT OCCURRED AS OF 19 OCTOBER).

3. BOSCH IS ORGANIZING A "SECRET CELL" OF THE MIRR WHICH WILL CARRY OUT ACTIONS AGAINST SHIPS. IN ORDER TO AVOID COMPROMISING PLANS OF THE MIRR, MOST MEMBERS AVOID GOING TO THE MIRR OFFICE, HOWEVER, MARCELINO GARCIA JIMENEZ, CHIEF OF THE THE DIRECTORATE OF THE MIRR, AND SERVELIO GUTIERREZ CONCEPCION, A MEMBER OF THE MILITARY SECTION AND A FEW OTHERS, CONTINUE TO VISIT THE OFFICE.

4. BOSCH SAID THAT THE MIRR HOPES TO ACCOMPLISH THE FOLLOWING AS A RESULT OF "THE DECLARATION OF WAR ON ENGLAND AND SPAIN:

A. AN INCREASE IN INSURANCE PREMIUMS FOR SHIPS IN THE CUBAN TRADE.

B. REFUSAL OF MERCHANT MARINERS TO WORK ABOARD VESSELS WHICH CALL AT CUBAN PORTS.
