INDIVIDUAL, BOSCH SAID IT WAS NECESSARY THAT THE INDIVIDUAL GO TO SAN
JUAN, PUERTO RICE, TO FICK UP A BOAT WHICH IS OWNED BY A NATIVE
PUERTO RICAN WHO HAD MADE IT AVAILABLE TO THE MIRR FOR THE PURPOSE
OF AIDING MIRR ACTIVIST OPERATIONS. ACCORDING TO BOSCH, THE BOAT IS
A FORMULA 225 (AS RECEIVED), 23 FEET LONG, AND IS DOCKED AT A
PIER IN SAN JUAN. THE BOAT POSSIBLY WAS TO BE TAKEN TO PLANAS KEY
(N 22-30, W 73-30); HOWEVER, THIS IS NOT DEFINITE. THE KEY,
ACCORDING TO BOSCH, IS ABANDONED AND WILL BE THE PLACE FROM WHICH
MIRR WILL OPERATE. BOSCH ALSO SAID THAT SOME WEAPONS (UNSPECIFIED)
WOULD HAVE TO BE PICKED UP AND TAKEN TO PLANAS KEY ALONG WITH THE
BOAT.

- 3. BOSCH WAS TO PROVIDE AIRPLANE TICKETS TO PUERTO RICO ON 11 MARCH AND LAST MINUTE INSTRUCTIONS FOR THE TRANSFER OF THE BOAT. (FIELD COMMENT: SUBSEQUENT INFORMATION INDICATES THAT THE UNIDENTIFIED INDIVIDUAL MAY HAVE DEPARTED FOR PUERTO RICO ON 12 MARCH.)
- 4. FIELD DISSEM: CINCLANT, CINCSO, CONKWESTFOR, MIAMI REPS OF STATE, USCG, BORDER PATROL, IGNS, FBI AND CUSTOMS.
