On 1 March 1965, Manuel Ray Rivero, leader of the Junta Revolucionaria Cubana (JURE, Cuban Revolutionary Junta), said that he and his group had changed their plans completely with respect to the fight against Communism in Cuba. He advised that the use of guerrilla tactics under the present regime would be almost impossible to accomplish. For this reason, he said, it would be preferable to begin operating clandestinely in the large urban centers and then slowly expand operations to the rural areas of Cuba.
 2. Ray advised that for the present time he has no action plans directed against Cuba.
