3. REQUEST YOU ADVISE AMHAWK CONTENTS PARA 1 AND DETERMINE WHEN AMHAWK CAN ARRIVE PEPRIME FOR MEETING WITH AMPALM AND AMMAIL GROUPS. FOR PROTECTION RUBIO WE PREFER YOU AVOID DISCLOSURE HIS PLANS TO AMHAWK ALTHOUGH WE RECOGNIZE AMHAWK MAY ALREADY BE AWARE OF THESE. CABLE HIS ETA.
4. CONCERNING POINTS RAISED BY AMHAWK IN PARA 3 OF HAVA 3708 (IN 11327):
 - A. ODYOKE WILL GUARANTEE ENTRY KEY LEADERS AND FOLLOWERS.
 - B. ECONOMIC ASSISTANCE WILL BE FORTHCOMING.
 - C. PEDRAZA DEPARTED MIAMI 23 MARCH FOR DOM REP. WE WILL TAKE STEPS PREVENT HIS REENTRY. ODYOKE ALSO PRESSING FOR REMOVAL CERTAIN OTHER NOTORIOUS BATISTA PEOPLE FROM MIAMI AREA ALTHOUGH OUR OWN SYSTEM OF PROTECTION OF INDIVIDUAL RIGHTS IS AN ADMITTED HANDICAP WHICH MANY
