1. ANDRES ZAYAS "JUSTO", LUIS SANCHEZ "PICOLIBO", AND TONY NUÑEZ "TONY" OF UR AND ANGEL ROSS "GUILIN" OF MRRC LEFT HQS P.M. 29 SEPT FOR WAVE.

2. JUSTO WAS SPONSOR AND DEFINITE LEADER OF GROUP INCLUDING ROSS AND HIS MRRC. JUSTO MADE GOOD IMPRESSION AND SEEMED SINCERE, CAPABLE AND TO KNOW WHAT HE WAS AFTER AND WHERE HE WAS GOING. ALTHOUGH SOME OF THE OTHERS WERE TRYING TO POLITIC JUSTO SEEMED TO BE INTERESTED ONLY IN A UNIFIED RESISTANCE EFFORT. 3. THEY ASKED IF THEY HAD TO GO THROUGH AMBUSH-1 AND WERE TOLD THEY COULD DEAL DIRECTLY WITH PETERS. PHONE NUMBER OF JUSTO FOR CONTACT IS FR-3-1306. THAT OF BOSS IS HI-3-7097. HOWEVER, LEAVE DISCRETION HAVE USE CUTOUTS.

4. NO COMMITMENTS WERE MADE. THEY WERE ASKED TO COOPERATE WITH AMBUSH-1 TO GET ALONG WITH TLM AND USE HIM BUT NOT FIGHT HIM AND AFTER MAKING THIS ATTEMPT IF THEY STILL COULD NOT GET ALONG WITH AMBUSH-1 WE WOULD NOT GIVE SUPPORT.
