1. NOV 28 AMBAIL-5 AND AMBRONC-1 BRIEFED KEATOR ENZEL ON TRAV TRIP. STATED TRIP BENEFICIAL BOTH THEMSELVES AND TRAINEES. GAVE LATTER CHANCE AIR COMPLAINTS WHICH WERE FEW AND GAVE MILCOM VIEW PROGRESS AND CONDITIONS TRAV. SUGGESTED REPEAT IN THREE TO FOUR WKS.

2. AMBRONC-1 STATED MOST COMPLAINTS CENTERED TWO MAIN ISSUES (1) AT PRESENT AMCIGAR HAD NOT PRESENTED TROOPS CLEAR CUT IDEOLOGY ON QUOTE WHY WE FIGHT UNQUOTE. AND (2) INDICATIONS RECENT ASSIGNMENTS TRAV MADE TO APPEASE POL GROUPS NOT BY SELECTION BASED ON MERIT AND LDRSHIP AS WAS PROMISED TRPS WHEN SENT TRAV. SAID HAD ACCEPTED PRESENT ASSIGNMENTS BUT EXPRESSED DESIRE REVIEW FUTURE ONES. CONSIDERED SEPARATION AND MOVEMENT TEAMS AND STRIKE FORCE EXCELLENT BUT SHOULD MOVE FM [GUAT] FOR SECURITY REASONS.
