1. FOLL MAY BE DISCUSSED [LIAISON]

A. ROJAS FOUND PATH TO FRD MUCH FASTER THAN ANTICIPATED. SINCE RICARDO LORIE HAS PAST TROUBLES JOINING FRD HE POUNCED ON DIPLOMATIC TALENTS HIS OLD FRIEND ROJAS AND ASKED LATTER ASSIST HIM NEGOTIATIONS WITH PBPRIME AND INDIGENOUS FRD CONTACTS.

B. THEREAFTER WAS ESTABLISHED THAT ROJAS WILL ATTEMPT JOIN FRD IN AS YET UNDETERMINED CAPACITY, INTENDS SETTLE PBPRIME, RETURN ONLY BRIEFLY LOND GET HIS FAMILY.

C. ABOVE INFO DEVELOPED AFTER DISCUSSION 27 SEPT BETWEEN ROJAS AND KURARK REP. TALK CENTERED AROUND FRD AND CUBAN EXILE ACTIVITIES GENERALLY.

A. FOR MANY REASONS HQS THOUGHT TIME RIPE BRING LORIE INTO FRD FOLD. THIS 3 OCT MEETING LORIE, ROJAS, WALLACE R. PARLETT ALIAS BENDER CAME ABOUT AT WHICH PARA 1 INFO RECEIVED. DURING MEETING ROJAS REPEATEDLY STRESSED WITHOUT PROMPTING THAT HE NOT BRITISH AGENT.

ALSO PROPOSED HE (ROJAS) HEAD FRD SABOTAGE DEPT SINCE HE HAD MANY GOOD CONNECTIONS WITH EXPERTS THIS FIELD SUCH AS <sup>06</sup> (JECCHIHLIS) BENDER ICE COLD THIS PROPOSAL FOR OBTENSIBLE REASON THAT PERHAPS WAS UNWISE INVOLVE HIGH CUBAN CITIZENS I.E. <sup>06</sup> (JECCHIHLIS) IN CUBAN FIGHT.

B. ROJAS DURING DISCUSSION WITH BENDER INQUIRED WHETHER HE SHOULD ASK <sup>24</sup> (OFFICIAL BRITISH) FRIENDS MAKE CARIBBEAN BASES AVAILABLE FOR ANTI CASTRO OPS. BENDER REPLY WAS IN NEGATIVE.

C. ROJAS REQUESTED BENDER ASSISTANCE BRING MOTHER FROM CARA TO PBRIME.

D. IN LIGHT REF B, HQS WILL ATTEMPT NEUTRALIZE ROJAS TO EXTENT POSSIBLE.
