1. SINCE MEETINGS DESCRIBED REFS A AND B INTERNAL ANYUM-1 GROUP WAITING FOR BOTH FINANCING AND GUIDANCE FROM FRD/AMBIDY-1. ON 8 AUG ANYUM-1 REPORTS TO ANSAL-1 THAT HIS ANYUM GROUP ON VERGE DISINTEGRATING DUE LACK OF FINANCES. INTERNAL ANYUM-1 GROUP HAVE RECEIVED NO FINANCIAL AID FROM FRD TO SUPPORT PLANNED OPS AND NO RECENT GUIDANCE FROM FRD/AMBIDY-1 AND MEMBERSHIP DISSILUSIONED. ANYUM-1 HAS BEEN RAISING SMALL AMOUNTS MONEY ON HIS OWN AND USING HIS PERSONAL FUNDS KEEP ANYUM TOGETHER BUT CLAIMS AT END HIS AND DONATED RESOURCES

2. STATION HAS NOT FUNDED ANYUM-1 ORC TO DATE. OUR UNDERSTANDING IS THAT PESO SUPPORT FOR INTERNAL ANYUM ORG TO FLOW FROM FRD PER REF C SINCE CONTROL, DIRECTION AND OVERALL UNIFICATION FACILITATED BY USE THIS CHANNEL. HOWEVER ANYUM ORG CANNOT OPERATE WITHOUT FUNDS AND REAL DANGER EXISTS THAT ORG WILL DISSOLVE UNLESS FINANCED FROM SOME QUARTER SOONEST.

3. ANYUM-1 CLAIMS THAT LORIE FACTION OF ANYUM PRACTICALLY NON EXISTENT INTERNALLY. CLAIMS HE HAS CONTACTED AND RECRUITED SOME FORMER LORIE ADHERENTS BUT UNABLE LOCATE ANY REAL STRENGTH CLAIMED BY THIS FACTS

4. ANYUM GROUP RECEIVED ANSWER OF BORDONET TO REF D LETTER. BORDONET STATES WANTS NO PART OF FRD SINCE IT "CONTROLLED BY AMERICANS" AND HE REFUSES WORK WITH AMERICANS.

5. RE PARA 3 ABOVE: STATION AWARE THAT POLITICAL SPLIT ANYUM WASH REFLECTED SUCH STATEMENTS HERE. HOWEVER, ANYUM GROUP CONTINUES AS ONLY STATION CONTACT INTERNAL ANYUM AND HAVE DISTRIBUTED MOST OF PROPAGANDA SENT BY HQS AND WASH. IN ADDITION HAVE USED LEAFLET BOMBS WITH SOME EFFECT ON HAVA POPULACE, PUT UP POSTERS, GENERATED ANYUM WALL WRITINGS, ETC. IN ORDER NOT LOSE EVEN THIS LIMITED ACTION CAPABILITY IT IS SUGGESTED THAT ADEQUATE FUNDING BE INITIATED IMMEDIATELY THROUGH THE AMBIDDY 1 CHANNEL OR STATION BE AUTHORIZED FINANCE DIRECTLY THROUGH AMPAL-1. ALSO REALIZE UNDER THEORETICAL INTERNAL FRD SETUP AMWAIL-9 AS FINANCIAL SEC SHOULD PROVIDE FUNDS ANYUM-1 GROUP, HOWEVER AT THIS POINT INTERNAL FRD APPARENTLY NOT FUNCTIONING.
