1. RE PARA 1 REF A, ENZEL WAS IN DAILY CONTACT ⁽⁹⁾OCOVE GROUP HOWEVER AVOIDED DETAILED DISCUSSIONS AS STILL AWAITING KUBARK POSITION FOLLOWING NEW YORK TALKS.
2. RE PARA 2 REF A, ENZEL MAINTAINING PERSONAL RAPPORT ⁽⁹⁾OCOVE GROUP, URGING THEM MAINTAIN POSITION WHICH WILL MAKE CONTINUED COOPERATION POSSIBLE. THEY, OF COURSE, PRESSING FOR SPECIFIC ANSWERS THEIR QUESTIONS FUTURE RELATIONSHIPS WITH BENDER WHICH ENZEL ^(U)UNWILLING/UNABLE ANSWER.
