VISIT PARI.

2. THIS DEVELOPMENT REVIEWED WITH SAL INTRC WHO BRIEFED US  
ON HOS ARRANGEMENTS TO ATTEMPT CUBELA DEFECTION DURING FESTIVAL.  
SINCE DO NOT WISH U/2 INADVERTENTLY COMPLICATE HOS PLANS, WOULD  
APPRECIATE HOS VIEWS ON GUIDANCE OF U/2 RE CUBELA'S WINTERGERST  
WILL HAVE CONTACT WITH U/2 IN HELS.

3. ALSO REQUEST HOS GUIDANCE ON GENERAL PROBLEM CUBAN  
DEFECTIONS. WHILE RECOGNIZE STRICT CRITERIA APPLYING TO  
ACCEPTANCE DEFECTORS, SUGGEST MAY WISH ADOPT LESSER STANDARDS  
FOR INDIVIDUALS WILLING DEFECT HELS OR COPE WITH ATTENDANT  
PUBLICITY NEGATIVE TO FESTIVAL.
