Suave: (a nickname for UNSMAFU/9)

Today I spoke to a friend in the Ministry of Foreign Relations. He explained your situation well enough (or, it may be, correctly enough): he told me that they had sent your Cuban passports back, something that has never been done/before to anyone.

(He also said) that you both can come back whenever you want to, to your country.

This made me very happy because your situation has been completely clarified.

I should be happy to hear from you as soon as you receive this letter.

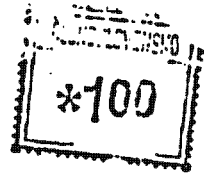
"El loco" Alberto arrived two days ago, to everyone's surprise, but goodness, that's the way he is. It seems that he was nostalgic for his country.

This letter was delayed a long time in reaching you because Venegas also delayed (his return) a long time here - because the CHEKA/scares him. (or Czechoslovakia -hard to tell, here)

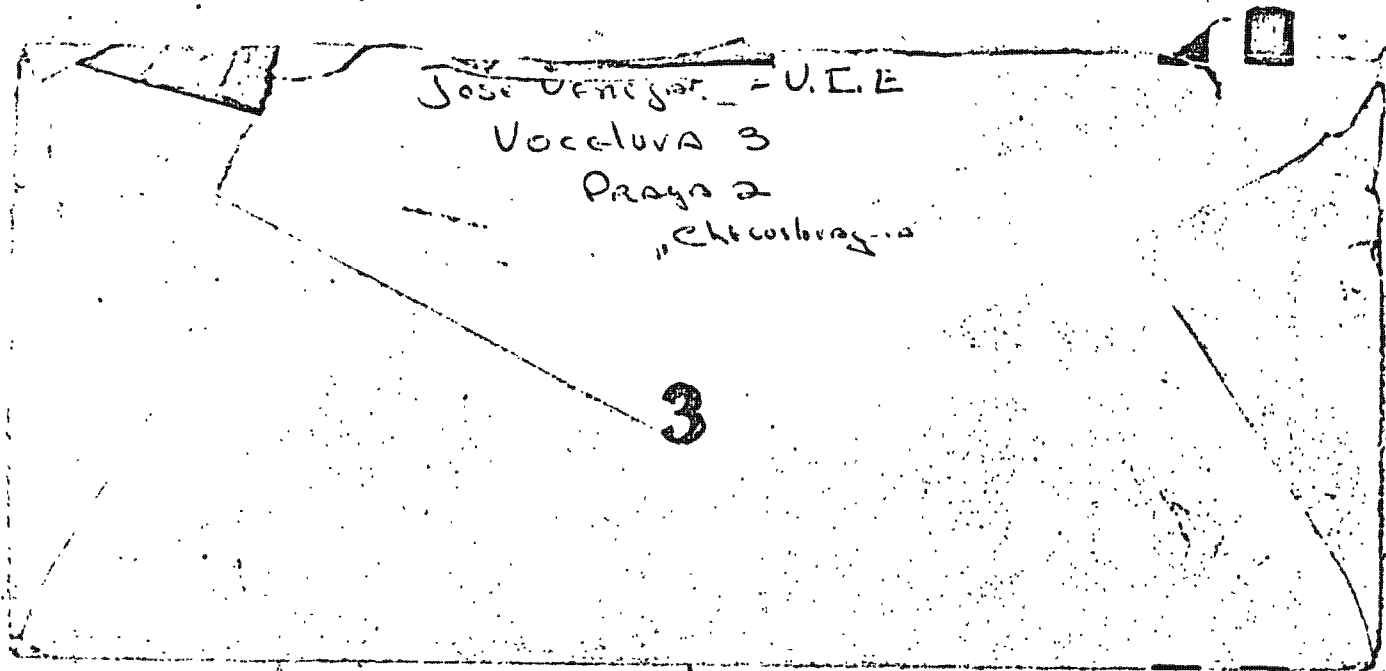
