1. REF VERY INTERESTING. WOULD APPRECIATE EXACT SPANISH WORDING OF TRANSCRIPT AND, IF POSSIBLE, OBTAIN TAPE.

2. OSMANI MENTIONED PARA TWO REF PROBABLY OSMANI CIENFUEGOS, CHAIRMAN OF CUBAN CP FOREIGN RELATIONS COMMITTEE AND SECRETARY GENERAL OF AFRO-ASIAN-LATIN AMERICAN PEOPLES SOLIDARITY ORGANIZATION.

BARBAROJA IS MANUEL PINEIRO, HEAD OF GENERAL DIRECTORATE OF INTELLIGENCE AND ALSO MEMBER OF PARTY FOREIGN RELATIONS COMMITTEE. THIRD MEMBER OF FOREIGN REL COMMITTEE IS FOREIGN MINISTER RAUL ROA, WHO ACCORDING OTHER SOURCES PLAYS SECONDARY ROLE TO CIENFUEGOS AND PINEIRO, BOTH OF WHOM IDENTIFIED WITH HARD LINE EXPORT OF REVOLUTION POLICY.

3. WHILE QUITE POSSIBLE THAT CARRILLO OUSTER BEING BLAMED ON CUBELA MATTER, INFO FROM OTHER SOURCES INDICATES THAT HE MAY HAVE BEEN FIRED FOR OPPOSING TACTICS FOR EXPORT OF REVOLUTION ESPOUSED BY CIENFUEGOS AND PINEIRO. VARIOUS RELIABLE REPORTS SHOW CARRILLO STILL
