DESENSITIZED TYPIC YOBITE AMLASH

REF: DIR 22695

1. FOLLOWING IS TRANSLATION OF SW MESSAGE FROM AMLASH/1. PARIS WAS REQUESTED TO RETRIEVE TWO PREVIOUS LETTERS AND WARN AND BRIEF UNSNAFU/9 ACCORDINGLY.

2. "MESSAGE #3. THE TWO PREVIOUS SECRET MESSAGES WERE HAND CARRIED. THE PERSON WHO CARRIED THEM DID NOT KNOW WHAT HE WAS CARRYING. YOU SHOULD RECOVER THEM, SINCE IT APPEARS THAT MY FRIEND (UNSNAFU/9) DID NOT KNOW THAT THERE WAS ANYTHING IN THEM.

WHEN A LETTER REACHES THE INDICATED PERSON (UNSNAFU/9) BY ANY MEANS HAND CARRIED OR AIRMAIL IT WILL ALWAYS CONTAIN A MESSAGE, AS I HAVE RECEIVED THE ITEMS NECESSARY TO COMMUNICATE WITH YOU. IF YOU MUST SEND ME A MESSAGE, YOU CAN DO IT THROUGH THE SAME CHANNEL (~~SECRET~~)

*103* ~~DELIVERED BY MAIL~~ (RESTINA (ACOSTA) GONZALEZ, [redacted] HAVANA). IT APPEARS TO ME TO BE SAFER AND FASTER THAN VIA MIAMI (AMTRUNK/10 CHANNEL).

ADVISE MY FRIEND THERE (UNSNAFU/9) THAT HE MAY LOSE HIS POSITION IF HE DOES NOT ACT WITH MORE DISCRETION AND STOP TALKING SO MUCH.
