UN POST ACCEPTABLE BUT OPS CONDITIONS AND UTILIZATION SOMEWHAT RESTRICTED THERE, THUS U/9 PRODUCTION CORRESPONDINGLY LIMITED. IF RETURN HAVANA MANDATORY, WOULD DEFINITELY WISH CONTINUE CONTACT, HOPEFULLY DEVELOPING HIM INTO GOOD REPORTER.
