1. NUMBERS VENEZUELA FLN TRAINING IN CUBA AT ONE TIME USUALLY SMALL. CUBANS ONLY TRAIN CADRES AROUND WHICH LARGE GROUPS CAN BE ORGANIZED INSIDE VENEZUELA. TRANSPORTATION SERIOUS PROBLEM WHEN LARGE NUMBERS INVOLVED, ESPECIALLY WHEN TRAVEL VIA PRAGUE REQUIRED. TRAINING CADRES AND FINANCING CONSTITUTES PRIMARY SUPPORT TO FLN. CASTRO IS AGAINST SENDING CUBANS TO VENEZUELA OR ANY OTHER LATIN AMERICAN COUNTRY AS GUERRILLAS. SINCE BEING CONDEMNED BY OAS, CASTRO IS MORE CAUTIOUS BUT CONTINUES SUPPORT FLN AND OTHER REVOLUTIONARY GROUPS IN LATIN AMERICA. SOME MONEY TO FLN IS BEING CHANNELLED THROUGH BEN BELLA AND ALGERIA, POSSIBLY ARMS, BUT ANLASH ONE STATES THIS HEARD AS RUMOR.

2. IN EARLY NOVEMBER 64, ANLASH ONE SAW HERMAN LAIRE, ^{Subject with} VENEZUELAN UNIVERSITY STUDENTS ORGANIZATION, IN PRAGUE. LAIRE WAS EN ROUTE HAVANA, ^{early Nov 64} PLANS WORK FLN OFFICE WHICH LOCATED ACROSS STREET FROM FOX BUILDING, HAVANA.

3. FROM TALKING TO DIFFERENT GOC OFFICIALS, ANLASH ONE GAINS IMPRESSION VENEZUELAN FLN POSSIBLY PRIMARY RECIPIENT CUBAN SUPPORT. THE PRIZE FOR CAIRO IS BIG. ^{BT MORE IMPORTANT REASON FOR SUPPORTING} FLN IS ITS FAIRLY EFFECTIVE ORGANIZATION WHICH CONTINUES TO OPERATE IN VENEZUELA.
