RHAT TYPIC AMWHIP MHAFRON AMLASH

1. (FNU) IGLESIAS, HAVANA JEWELER AND FRIEND AMLASH ONE, TELEPHONED AMWHIP 2 IN GENEVA 1 NOV SEEKING AMWHIP 1. WITHOUT APPARENTLY REVEALING AMLASH 1 NAME, SAID HAD QUESTION FROM FRIEND OF AMWHIP 1 WHICH WAS: IS ANSWER YES OR NO? IGLESIAS ASKED THAT AMWHIP 1 TELEPHONE HIM IN HAVANA. THIS QUESTION WAS ONLY PURPOSE CALL.

2. AMWHIP 1 CANNOT TELL WHETHER MSG REFERS MERELY TO MEXICAN INVITATION OR TO BROADER QUESTION. STOCKWOOD VENTURED VIEW HQS WILL NOT ANSWER ONE WAY OR OTHER IF INQUIRY RELATES TO BROADER QUESTION AND CERTAINLY NOT IF ANSWER TO GO BY TELEPHONE. HOWEVER SINCE MEXICAN INVITATION MAY BE INVOLVED AMWHIP 1, WHO DOES NOT KNOW WHETHER OR NOT AMLASH 1 RECEIVED IT, SUGGESTS HE COULD CALL MEXICO BEFORE TALKING WITH IGLESIAS. REQUEST HQS COMMENT TO ARRIVE BY 1100 LOCAL 3 NOV.

3. PRELIMINARY ANSWER PARA SIX DIR 58389 IS AMLASH 1 VERY CLOSE TO CALIXTO GARCIA MARTINEZ BUT MORE SO TO PEDRO MIRET FRIETO AND MUCH LESS SO TO FAUSTINO PEREZ HERNANDEZ. SEEKING MORE DETAILS.
