1. PURPOSE AMLASH-3 TRIP PARIS WITH MIGUEL "CUCO" DE LEON WAS FOR MEETING WITH AMJAVA-4, AMWORLD REPRESENTATIVE. AMLASH-3 CLAIMS INTERNAL DISSIDENT GROUP OF WHICH HE MEMBER ANXIOUS ARRANGE "SUMMIT" MEETING BETWEEN TOP MAN OF GROUP AND AMBIDDY-1 FOLLOWED BY PACT AND UNION AMWORLD AND INTERNAL GROUP. THEY ALSO DESIRE ESTABLISH SECURE RADIO LINK BETWEEN GROUP AND AMBIDDY-1. AMLASH-3 INFORMED AMJAVA-4 THEIR MAN IS EXPECTED OUT AND AVAILABLE FOR MEETING BETWEEN 15 AND 30 NOVEMBER. IF THEIR MAN IS UNABLE TRAVEL TO EUROPE, THEY WOULD THEN PROCEED ARRANGE BOAT RENDEZVOUS AND MEETING ON THE HIGH SEAS. ALTHOUGH NO NAMES WERE MENTIONED BY AMLASH-3, AMJAVA-4, BASED ON TWO LENGTHY MEETINGS, BELIEVES COMANDANTE EFIGENIO AMEIJERAS MAY BE INDIVIDUAL COMING OUT OF CUBA FOR MEETING. AMJAVA-4 IS CONVINCED FOLLOWING INDIVIDUALS INVOLVED WITH AMEIJERAS: AMLASH-1; FAUSTINO PEREZ, DIRECTOR HYDRAULIC INSTITUTE; JUAN ALMEIDA, FIRST VICE MINISTER OF DEFENSE; JUAN NUIRY SANCHEZ, PROFESSOR HAVANA UNIVERSITY AND JOSE "PEPIN" NARANJO, MAYOR OF HAVANA.
