1. NO OBJECTION ANWAX-1 TRAVEL DOMREP TO MONITOR ANWORM-1 ACTIVITIES. PLEASE KEEP HQS ADVISED ANY FURTHER REPORTS THIS SOURCE.
2. AMBIDY-1 HAS REPORTED HE TOLD BY AMLASH-1 THAT AMLASH-3 (IDEN) TO BE SENT DOMREP BY CIS TO PENETRATE EXILE GROUPS AND MONITOR THEIR ACTIVITIES. THIS TENDS CONFIRM REF PARA 2 ANALYSIS. AMBIDY-1 INTENDED WORK OP OUT WITH EMOTH-12 TO ALLOW AMLASH-3 MONITOR AND REPORT TO CIS ON EXILE ACTIVITIES IN RETURN FOR HIS REPORTING ON CIS ASSETS AND OPS IN DOMREP. AFTER DEPARTURE AMLASH-3 FOR NICARAGUA (HIS NEXT CIS TARGET), DOMREP WOULD ROLL UP CIS NETS.
