1. BELIEVE OP PROPOSED BY AMLASH/3 TO BE QUASI-OP AND HIGHLY IMPROBABLE; HOWEVER, AMLASH/3 AND UNSNAFU/9 IMPROBABLE ENOUGH TYPES THAT THEY MAY HAVE DREAMED UP SCHEME OF THIS NATURE IN AFTERMATH OF ENTRY U.S. TROOPS IN SANTO DOMINGO.

2. IF STATION BELIEVES IT CAN OBTAIN FURTHER INFO SAFELY, CONCUR IN ITS EFFORTS HAVE MIRRLEES MEET ~~CONCURRENCE~~ ^{AGAIN} WITH UNSNAFU/9 TO ELICIT MORE DETAILS. MIRRLEES MUST BE EXTREMELY CAREFUL MAKE NO STATEMENT TANTAMOUNT TO ~~EXPLICIT~~ ACCEPTANCE OF RECRUITMENT.

3. BECAUSE UNSNAFU/9 DID NOT MENTION RECRUITMENT AND SOV CONTACT OFFER TO GLOADEN, PROBLEM IS TO EXPLORE TO EXTENT POSSIBLE WITHOUT UNDUE RISK SERIOUSNESS OF PROPOSAL AND IDENTITY ALLEGED SOV. ACCORDINGLY, STATION SHOULD BE PREPARED TO SURVEIL UNSNAFU/9, AFTER MEET WITH MIRRLEES TO ASCERTAIN WHETHER HE CONTACTS ^{SOV OR} SOV CUTOUT.

4. IF FOREGOING PROCEDURE IS NOT PRODUCTIVE, STATION SHOULD CONSIDER CONFRONTATION OF UNSNAFU/9 TO DETERMINE WHETHER OR NOT WHOLE PROPOSAL FOR SOV INVOLVEMENT WAS MERE TALK.
