COMMENCING SHORTLY AFTER GUTIERREZ MENOYO WAS DETAINED IN JAN 61 BY  
 GEORGE KUBARK AND APPROPRIATE OVERT AGENCIES WERE CONTINUALLY REQUESTED BY  
 ANGBANG-ONE, AMBUD-ONE AND PRIO <sup>SOCARRAS</sup> TO OBTAIN RELEASE OF GUTIERREZ. NO  
 ACTION WAS TAKEN ON THESE REQUESTS EXCEPT THAT IN LATE APR HQS INFORMED  
 GEORGE THAT KUBARK NO LONGER INTERESTED IN CONTINUED DETENTION. GEORGE  
 REPLIED THEY WOULD CONTINUE DETAIN HIM ANYWAY. THIS LAST HQS INFO RE  
 GUTIERREZ UNTIL WAVE REPORTED HIS RELEASE.

\*MR COBEN: Reported release of Kloy GUTIERREZ Menoyo inciting strong  
 reaction among Cubans in Miami and much criticism of AMBUD-1  
 as being responsible for getting him released. Said WAVE  
 unaware AMBUD-1 sponsored or responsible for release and  
 requested Hqs provide any details.
