1. 26 JULY LABOR LEADERS CTC MET WITH FIDEL CASTRO
21 JAN TO URGE HIS SUPPORT ISSUANCE GOVERNMENTAL DECREE ALLOW
26 JULY LEADERS COMPLETE TAKE OVER CTC.

2. DURING MEETING THEY SPECIFIED DECREE COMMIE INFILTRATION
CUBAN LABOR AND POINTED OUT ORGANIZATIONAL THREAT TO 26 JULY
LABOR WHICH THIS ENTAILED. AS RESULT MEETING CASTRO CONTACTED
PRESIDENT AND MIN LABOR RESULTING IN ISSUANCE OF DECREE 22 JAN.

3. DURING SAME MEETING CTC LEADERS ABLE ASCERTAIN CASTRO
AND TOP GOVERNMENTAL FIGURES SUCH URRUTIA CONTEMPLATING ISSUING
DECREE OVER HAULING ELECTORAL LAWS AND MAKING IT REQUIREMENT THAT
IN ORDER BE RECOGNIZED ANY PARTY MUST BE ABLE PROVE ITS
REGISTRATION PRIOR ELECTIONS EQUAL AT LEAST 5% ELIGIBLE VOTERS.

PARTICIPATING IN ELECTIONS AS PARTY.
