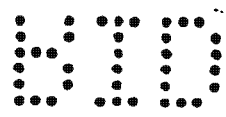

LATTER INFO TO AMSIGH-2 RATHER THAN AMCALL-1 WIFE.

3. WISH CORRECT WHAT MAY HAVE BEEN ERRONEOUS IMPRESSION RE AMSIGH-2 INVOLVEMENT AMCALL-1 CASE. DURING LAST VISIT MIAMI AMECRU-1 AT FIRST ATTEMPTED STEER AMCALL-1 FAMILY LIAISON, AS WELL AS THAT OF AMPANIC-7 CASE, THROUGH AMSIGH-2. HE LEARNED THAT AMCALL-1 WIFE HAD "HIGH LEVEL CONNECTIONS" AND OVER LUNCH TABLE DEBRIEFED HER ON THIS SUBJECT. INCLUDED CONTACTS WAS VANISTENDAEL WHO ALLEGEDLY HAS "IN" WITH VATICAN HIERARCHY. AMECRU-1 HAS SINCE DEALT BOTH WITH AMSIGH-2 AND AMCALL-1 ON AMCALL-1 CASE. AMECRU-1 HAS TRIED TIE AMCALL CASE INTO HIS PET PROJECT FOR RELEASE 400 PRISONERS, APPARENTLY IN HOPES EVENTUALLY LIFE UP FINANCING FOR THIS PROJECT THROUGH VATICAN AND JKLANCE. LAMADRIZ (201-859862), BUT IN 21 MAY CALL TO BINIARIS SHE SAID VILLAVERDE FAMILY HAD RAISED \$12,000. SHE ARGUED THAT ON HUMANITARIAN GROUNDS JKLANCE SHOULD HELP OUT AND PROPOSED THAT IF AMECRU-1 ABLE NEGOTIATE AMCALL-1 CASE AT FIGURE LESS THAN \$100,000, THE REMAINDER OF THAT SUM SHOULD BE PUT IN "VILLAVERDE KITTY". BINIARIS SAID HE RESPONDED THIS OVERTURE BY REITERATING PREVIOUS LIKE VILLAVERDE CASE RE NO JKLANCE OBLIGATION.
