1. AMECRU-1 TELEPHONED WIFE AMCALL-1 LATE NIGHT  
 17 MAY AND IN COURSE CONVERSATION SAID:

A. AMPANIC-7 WAS SCHEDULED LEAVE CUBA WITH  
 AMRIPE-2 BUT IN LAST MINUTE INTERROGATION AMPANIC-7  
 REFUSED TO TALK, BECAME BELLIGERENT AND UNCOOPERATIVE  
 AND WAS REINCARCERATED.

B. GOC ANXIOUS TALK TO AMECRU-1 PERSONALLY;  
 CLAIM THEY WISH DISCUSS AMCALL-1 CASE. THEY HAVE

 GOC THAT IF HE TRAVELS CUBA AND THERE IS AGREEMENT  
 ON AMCALL-1 RANSOM, AMCALL-1 IS TO RETURN WITH  
 AMECRU-1. TO SPAIN.

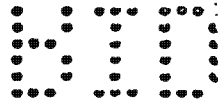
