MEMORANDUM FOR: WH/4/Finance

SUBJECT: Overdue Accounts

1. ACQUIP-1 - In July 1960, Headquarters advised Station Bogota that Subject with two aides would be traveling to PEPRIME to assume the post of Navy Chief in the FRL Directorate and visa assistance was requested. Routine difficulties followed including no funding by the FRL until finally in August 1960 the Station had to advance funds for Subject and one companion including \$150 each required by the Consulate as evidence of solvency. There is no indication in the files as to whether this \$300 was to be absorbed as a KUBARK expense or whether it was to be repayed. However, since that time, ACQUIP-1 has become a security risk. He is considered an opportunist and associates with people with whom KUBARK wishes no contact. One of these individuals is described as needing only the slightest excuse to make public statements embarrassing and harmful to KUBARK interests. Accordingly, it is recommended that this advance be written off without attempting to secure repayment.

2. ANCALL-1 - Funds were passed to ANCALL-1 by the principal agent for use in the ANCALL project. However, as conventional political action on the labor front became more and more difficult, these funds made their way increasingly into the MRP war chest since ANCALL-1 was national co-ordinator for this organization. Finally, the taking over of the labor movement by the Communists left no room open to opposition elements except that of sabotage and clandestine activity. In April 1961, Gordon HILARIAS, principal agent with whom ANCALL-1 was in contact was arrested and ultimately deported. There was no further contact with ANCALL-1 following the arrest of HILARIAS. The funds that had been passed to him were presumably used by the MRP underground and must have been gone long before the time of ANCALL-1's arrest the end of September 1961. Accordingly, WH/4/PA-PRCP is requesting that the sum of \$840.81 charged against the agent be written off both because the funds were undoubtedly expended by the MRP underground in furtherance of anti-Castro objectives and because ANCALL-1 himself is either dead or in prison and accountings can therefore not be secured.

3. Jedre DIAZ Lanz - The sum of \$400 was passed to Subject on 19 January as expense money for a prep tour he was to take along with

Luis COSTE Aguerre and other Cubans. The plan called for the use of DIAZ' Lora's plans piloted by him. This was changed when it was found to be too difficult to get the necessary permits for the plans. Next, DIAZ and COSTE were going commercially, but neither wanted to be sponsored ostentatiously by the FRD. Finally, COSTE went alone when DIAZ balked at simply being COSTE's shadow. Meantime, DIAZ Lora had begun to dabble extensively in exile politics in Miami, appeared before a congressional committee and succeeded in making himself useless as a propaganda asset. MAVS was not in contact and Eqs finally considered it preferable not to request contact with him to try to collect the advance. In view of the subsequent time lapse, it is recommended that the advance be written off.

In nearly all instances there was no identification of the individuals; in a relatively few instances, there was a possible identification, but nothing conclusive. It was felt that Subject had talked a lot but said little.
