1. BINIARIS REPORTED MORNING 22 FEBRUARY THAT WIFE OF AMCALL-1 RECEIVED CABLE DATED 17 FEBRUARY FROM AMECRU-1 IN CARACAS. CABLE STATED HE ON VACATION IN CARACAS AND IF HE NEEDED AMCALL-1 WIFE COULD CABLE HIM AT MACUZ REPEAT MAGUZ IN CARACAS. NOTHING ELSE MENTIONED IN CABLE. ABOVE CABLE ONLY CONTACT WITH AMECRU-1 AFTER RETURN N.Y.

2. AMCALL-1 WIFE ALSO TOLD BINIARIS BOTH AMSIGH-2 AND SHE RECEIVED LETTER FROM AMECRU-1 FROM PARIS STATING AMECRU-1 HAD "BEEN TO SEE THE PEOPLE." AMECRU-1 SAID DEAL ^{STILL} ~~RETT~~ ON. HOWEVER DUE TO ACTIVITIES OF JOSE DE LA TORRIENTE "CONDITIONS NOT PROPITIOUS FOR NEGOTIATIONS AT THIS TIME. AS SOON AS CONDITIONS CHANGE NEGOTIATIONS WILL CONTINUE. MEANWHILE, ANY FAMILIES THAT WISH TO TAKE BACK THEIR MONEY MAY DO SO."
