1. UPON RECEIPT REF WAVE BEGAN IMPLEMENTATION PROP LINE RECOMMENDED BY HQS. HAD PLANNED SURFACE THIS PROP LINE CIRCA 1900 HOURS 27 JAN AS THIS EARLIEST RADIO TIME TO WHICH WAVE ASSETS COULD GAIN ACCESS. HOWEVER, FAST MOVING EVENTS DURING 27 JAN OVER TOOK REF GUIDANCE IN MANNER WHICH AFFECTED BOTH FEASIBILITY AND CREDITABILITY OF REF GUIDANCE.

PRIMARY FACTORS WHICH AFFECTED FEASIBILITY OF IMPLEMENTING REF WERE:

A. 27 JAN MID DAY SURFACING BY RADIO HAVANA OF GUTIERREZ CONFESION WHICH INDICATED HE TELLING ALL TO INCLUDE DESCRIPTION HIS OPS BASES DOMINICAN REPUBLIC AND BAHAMAS AND WAS IDENTIFYING ALL MEMBERS HIS GROUP LOCATED DR PLUS IDENTIFYING THOSE DR OFFICIALS WHO KNOWLEDGEABLE RE HIS OP OR FURNISHING LOGISITICAL SUPPORT.

B. SFNE OFFICIALS MIAMI, ACTING ON IMPLUSE RATHER THAN REASON, UNLEASHED POORLY DESIGNED PROP DISPLAY WHICH PLACED FLAME ON GUTIERREZ ROLL-UP ON BETRAYAL BY ASSETS IN CUBA. THIS LINE OF REASONING COUNTERED REF GUIDANCE PLUS CONTRIBUTED EFFECTIVELY TO UNDERMINING LONG ESTABLISHED WAVE PROP CAMPAIGN THAT CUBANS INSIDE CUBA WERE WAITING FOR CHANCE

2. DUE THIS FAST MOVING PROP SITUATION, IT NECESSARY MAKE AD HOC DECISIONS IN ORDER PUSH PR OP THEMES WHICH DESIGNED TAKE STING OUT OF HAVANA EXPLOITATION GUTIERREZ ARREST. HAVE DEVELOPED FOLLOWING PROP THEMES WHICH WILL BE BROADCAST STARTING 1830 HOURS 27 JANUARY:

A. MRP OR ALPHA 66 SPOKESMAN WILL ISSUE STATEMENT GUTIERREZ WAS THEIR STAUNCH ALLY, BUT HE REPRESENTED ONLY SFNE AND HAD NO KNOWLEDGE RE THEIR ASSETS IN CUBA; THUS, NO MATTER HOW GUTIERREZ TORTURED, SECURITY OF MRP-ALPHA 66 COLLABORATORS IN CUBA WILL NOT BE EFFECTED. SPOKESMAN WILL INDICATE STRUGGLE AGAINST CASTRO WILL CONTINUE AND HE CONFIDENT THEIR CONTACTS WITHIN POLITICAL AND MILITARY STRUCTURE OF CUBA WILL CONTINUE WAGE CLANDESTINE WAR AGAINST CASTRO.

B. SFNE SPOKESMAN WILL ASK FORMER SFNE MEMBERS WHO NO LONGER ACTIVE

BUT LIVE LAS VILLAS TO HONOR GUTIERREZ MENOYO BY WEARING SOME BLACK ARTICLE OF CLOTHING 31 JAN. SPOKESMAN WILL POINT OUT THERE NO PERSONAL RISK INVOLVED THIS MANEUVER AS WEARING BLACK TIE IS SYMBOLIC OF GRIEF AND NOT PUNISHABLE BY LAW. SPOKESMAN WILL POINT OUT SUCH ACTION NECESSARY FOR MAINTANANCE SOLIDARITY OF RESISTANCE FRONT AGAINST CASTRO.

C. SELECTED ASSETS WILL PLAY ICEBERG THEME, I.E. GUTIERREZ

ONLY ONE OF MANY RESISTANCE LEADERS WHO NOW ACTIVE CUBA. HIS CAPTURE
SIMPLY IDENTIFIES THAT ELEMENT OF ICEBERG WHICH ABOVE WATER; MOST

D. HEAVY PLAY WILL BE GIVEN SENATOR SMATHERS' 26 JAN SPEECH RE
FACT CUBAN ARMY CONSPIRING AGAINST CASTRO AND INTERNAL COUP D' ETAT
INEVITABLE. THIS THEME DESIGNED TAKE SOME PROP PLAY AWAY FROM
GUTIERREZ ARREST.

3. AMLYRIC 1 CONTACTED ANDRES (NAZARIO) SARGEN OF SFNE MIDDAY 27
JAN AND ADVISED HIM SFNE SHOULD NOT PUSH PROP THEME THAT GUTIERREZ
BETRAYED BY INSIDE CONTACTS. AMLYRIC 1 THEN ASKED NAZARIO MAKE STATEMENT
ALONG LINES PARA 2 B. NAZARIO AGREED THIS WORTHWHILE BUT INDICATED
WOULD PREFER POSTPONE DECISION UNTIL COMPLETION OF EXECUTIVE SESSION OF
SFNE, MRP AND ALPHA 66 LEADERS.
