2. Normally, headquarters will be unable to issue an approval unless requester furnishes answers to all questions in PRQ parts I and II. However, in an emergency provisional approval may be obtained by complying with the applicable provisions of FR 10-215, paragraphs 6a, 8, 12b and 12d. Thereafter the usual method to document or complete the case must be followed as set forth in FR 10-215.
3. Three (3) completed copies of PRQ part I (including copy in subject's handwriting, if possible) and two (2) completed copies of this form must be sent to headquarters as soon as possible.
4. Data acquired later must be sent to headquarters in PRQ format in two (2) copies.
5. Fill in all items, if information obtainable. If item not applicable write "NA." If additional space required for item, use reverse side of page keyed to appropriate item number.

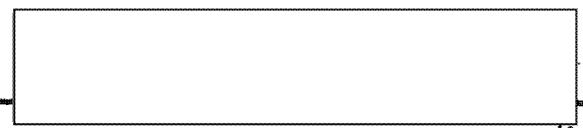

2. She undoubtedly is patriotic but disagrees strongly with certain FBRIME policies.
3. She is, at the time being at least, almost completely dependent on the KUEARK salary paid her.

Section XI, 5.

3. Security: She has proven to be reasonably security conscious, however, her intimate relationship with LINDLUCK, [redacted] and possible with others constitute potential security hazards. She is discreet in her phone conversations with the case officer, and in the mechanics of making meetings. She sometimes turns down meeting places suggested by the case officer, saying that some of her acquaintances visit the place or the area suggested, or that Soviet and/or Satellite personnel are believed to visit the place or area. The greatest potential security hazard, the writer believes, is the type of situation, sexual and/or emotional involvement, which she might allow herself to become involved in.

2. In an effort to pave the way for LINDLUCK's return to Mexico, she has interceded with various Mexican Government officials, and caused certain press articles in his defense to be published. This activity, however, was carried on with the knowledge and approval of KUBARK personnel. She provided copies of letters written, and received from LINDLUCK, clippings from the press, and summaries of her conversations with Mexican Government personnel.

Subject's address, telephone number, and a address made available by CIA in the Station. Should emergency contact be necessary, the person responsible for office of cover or in person, should attempt to establish contact with her. This case has been given to her for that purpose. Circumstances permitting, the true name of the present case officer could be used. No recognition signal, other than mentioned above, have been established, but this case should be handled as a normal assignment.

SECTION XVI MISCELLANEOUS OPERATIONAL DATA AND REMARKS

To the extent possible, subject should be mentioned frequently with regard to her contacts and assignments, necessarily for operational reasons, but also to assist her in avoiding potential pitfalls. Guidance must be positive and given with emphasis when necessary. She should definitely not be given any more information than is absolutely necessary for her to accomplish the tasks assigned her. Furthermore, as stated elsewhere, case officers selected to handle should be mature, and experienced and should not be younger than she. It is believed that an experienced female case officer of her approximate age could do as well, if not better, than a male case officer.
