1. Attached for your information and use is a copy of a statement by Dr. George FENWICKER concerning his and Dr. White's contacts with William Hamilton MARTIN at the Lebedev Institute in Moscow. (As you know, MARTIN is identical with the MARTIN who with MITCHELL defected to the Soviet Union in September 1960.) ODENVY and ODINCH are interested in having Dr. WHITE interviewed for complete and detailed information concerning his contacts with MARTIN and the girl secretary named Alla at the Institute. You may inform Dr. WHITE that ODENVY has requested that he be interviewed in this matter in connection with a matter of official interest to them.

2. Information available to Headquarters indicates that Dr. Roscoe WHITE is listed on the teaching staff of UCANVIL located in Trieste. Another Headquarters component has an interest in UCANVIL and has asked that the person who interviews Dr. WHITE provide a general assessment report concerning him. It is suggested that this be accomplished without Dr. WHITE's becoming aware of a possible operational interest in him. The assessment should be forwarded as a separate attachment to your report.

3. It is requested that Rome Station decide how this matter should be handled. It has been pending for some time since it appeared that Dr. WHITE might return to the States. It now appears he will remain abroad for another year. Therefore, it would be appreciated if his interview could be handled as expeditiously as possible and your communication marked for the attention of KUIESK.
